We're back! Back in person, that is, for the 2022 Annual NALA conference at the JW Marriott Desert Ridge Resort & Spa in Phoenix, Arizona. Even though there were many of us in person, there were others who joined us virtually for this first-ever hybrid event.

Excitement was in the air, and you could feel it everywhere you went. This was my first year being able to attend in person, and let me tell you, it was amazing! From the positive energy felt around, to all the wonderful new friends, to all the amazing speakers who gave insightful presentations, it was so much fun.

There were many sessions to choose from. A few sessions that stood out to me the most were 1) Police Shootings, Excessive Force, and the Constitution; 2) Social Media and Paralegals – Ethical Pitfalls; and 3) Are you guilty of UPL? Police Shootings, Excessive Force, and the Constitution. This particular session went over the courts' treatment of police officers' use of excessive or deadly force in the context of the U.S. Constitution. Social Media and Paralegals – Ethical Pitfalls discussed how to properly use social media without crossing ethical boundaries, basically the do's and don'ts. Are you guilty of UPL? examined the dangers of unauthorized practice of law, how to determine if it is being done and how to avoid it.


