## Message from Richard Hahn, ACP 2023-2024 Affiliated Associations Secretary


### Hello Affiliates!

Oklahoma Association of Legal Assistants on how local associations can do successful community outreach. *Continue reading...* 








## NALA Volunteer of the Month is a member of an Affiliated Association!



## Share Your Success: Will Your Association Take Center Stage at the 2024 NALA Conference & Expo?

Is your association achieving remarkable success that you are proud to have accomplished? Share your knowledge by presenting during the AA Annual Meeting by presenting for the Affiliate Exchange Program during the 2024 Conference & Expo!

Your insights can be incredibly beneficial for other Affiliated Associations facing similar situations. This exchange of ideas aims to foster mutual learning and growth. Your tips and tricks could be the key to helping others excel. If your association's proposal is not selected for the conference, you may still have a chance to present during a 2024 Affiliated Association Presentation. There are some exciting changes to the Certified Paralegal (CP®) Exam coming in January 2024! If you have members who are CPs, make sure they know that the recertification fee is changing for CPs who are not NALA members. Starting in January 2024, non-NALA members will pay \$175 to recertify, not \$125. For your aspiring CPs, please inform them of the new Bankruptcy section on the Knowledge Exam, beginning in January 2024.

There are also updates to eligibility requirements for the exam that you will want to share with your members. Under Category 1, student applicants can apply no earlier than 60 days before their expected graduation/program completion date. Under Category 3, applicants with a high school diploma or equivalent now only need five years of experience as a paralegal in addition to the required 20 hours of substantive CLE. Another exciting development is the reinstatement of partner testing in 2024. Partner testing allows schools, workplaces, and military bases to offer the CP® Exam at their location.

### Why take the NALA Census?

As 2023 will soon come to a close, your association members will want to update their individual NALA Account profiles to submit census data and have a chance to win \$100 and/or \$500! Association Presidents and NALA Liaisons, your encouragement is crucial for member participation. The Census informs NALA's decision-making, program development, and advocacy. We can share with you deidentified, aggregate census data for your association to drive improvements. Please help spread the word! Your association



participation is key to the continued growth of the paralegal profession.
