The form is titled 'CERTIFIED PARALEGAL RECERTIFICATION AFFIDAVIT' and includes the NALA logo and contact information. It contains the following text and fields:

**CERTIFIED PARALEGAL RECERTIFICATION AFFIDAVIT**

This form should not be completed or submitted earlier than thirty days prior to the expiration date of your certification and should only be submitted once the 50 hours of CLE credit, including five hours of legal ethics, have been recorded in your NALA account.

**NOTE: If you are a NALA member, your membership dues are separate from your certification.** If the Recertification form is mailed, it must be accompanied by a check, money order, or credit card information (VISA, Master Card, Discover, or American Express are accepted).
