# Designing Prompts for Artificial Intelligence to Create a Contract

The purpose of this discussion board is to think critically in designing prompts for artificial intelligence to create clauses for a contract. Note: you are not required to have an AI account to participate in this discussion. (Each group consists of 4 - 5 students.)

#### Scenario:

Jack O. Randa and O. Lee Anders, representatives of the community garden at College of the Canyons, met with their attorney, and the attorney is seeking your assistance in drafting a contract.

College of the Canyons has an on-campus community garden with approximately 100 raised bed plots, 4 feet wide x 10 feet long. Students may enter into a contract with College of the Canyons to use a plot to grow food and keep 1/2 of the food items for individual use and donate the other 1/2 of the food items to the BaNC (Basic Needs Center). The BaNC will provide those food items to students.







## Initial Post due by Thursday, 11:59 p.m.:

You may utilize one or more AI platforms:

Select at least two topics below and design two individual prompts to submit to an artificial intelligence platform to draft clauses.

### **Design a prompt that:**

1. Focuses on defining the roles and responsibilities of both the college and the participating students.

- 2. Explores potential liability concerns and risk management strategies within the contract.
- 3. Addresses property rights and allocation of garden resources, relating to garden plot allocation, ownership of crops, and access restrictions.
- 4. Delves into the dispute resolution mechanisms within the contract. What methods can be employed to resolve conflicts effectively?
- 5. Highlights the importance of sustainable practices within the community garden. What specific provisions should be included in the contract to promote sustainability?
- 6. Develop any other prompt outlining specific terms and conditions to be included within the contract.

## Responsive Posts due by Monday, 11:59 p.m.:

After submitting your individual prompts, respond to two of your classmates.

Review the prompts created by your classmates and provide constructive feedback by discussing the clarity, relevance, creativity, and/or effectiveness of the prompts. Ensure the prompts are clear, relevant, and innovative in their approach to engaging AI. Collectively, you will decide on the best prompts for each topic to submit to AI. (Yes, you may test-run the prompts. Be sure to provide the results within the discussion board so that all members in your group can determine if a prompt needs refining.)

## **Next Class Meeting via Zoom:**

As a group, you will have the opportunity to meet in a breakout room and refine your prompts to draft the community garden contract utilizing AI. As a class, we will review each group's contracts to discuss similarities and differences, clauses that AI introduced that may not have been prompted, and how **AI** is a tool for paralegals in drafting documents. (We may even vote on the best clauses or contract that AI generated and discuss why.)

Note: If you determine the group does not have access to AI, the instructor will provide assistance to the group to generate the contract with the prompts provided by the team.
