EVENT PLATFORM/ATTENDEE HUB

The conference attendee hub is the online event platform where you can join sessions, view the schedule, connect with other attendees, and visit the Virtual Expo Hall. 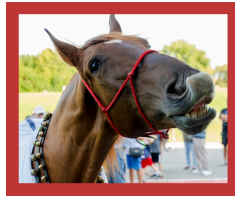
