# Get to Know... Cheryl Nodarse, ACP, NALA President

## What is your job title and which company do you work for?

I am an Advanced Certified Paralegal for the Vlahakis Cole Law Firm in East Lansing, Michigan.

# What led you to this career and how did you get into your current field or position?

### Paralegal to Law School - Round 2

The law school saying is, "the first year they scare you to death, the second year they work you to death, and the third year they bore you to death" and so far, that could not be any truer. Year two is completed and what a whirlwind it was! Just when I thought life could not get any busier than during my first year of law school, the second year snuck up and said, "hold my beer and buckle up!"

The first year of law school focuses on foundational courses and core legal principles needed to prepare students for the Bar exam. Upon completion of the first year, students can find themselves at a critical juncture in their education. While students have their 1L courses selected for them, starting in the 2L year, students select their own courses. This freedom poses a choice between focusing on Bar tested classes and/or selecting more specialized courses which align with their desired career interest. Personally, I want to do criminal, juvenile, and family law within my own solo practice. I chose to tailor my education to align with those career goals by taking classes such as Family Law, Criminal Procedure, ICWA, and Law Practice Management.



With that said, my second semester was filled with writing courses, and I only had two in-person finals. A paralegal's job is heavily focused on legal research and writing so this sounded like a dream come true with my previous 19-years of experience; however, it was more like a nightmare! Having multiple 25-page and 35-page writing projects was not as picturesque as it initially sounded. Further, I love to help and teach others, so I overextended myself (extremely self-inflicted) by adding other

things to my list like being an orientation leader and a teaching assistant ("TA"). I started the year serving as an Orientation Leader and Orientation TA for the incoming 1L class. That included greeting, mentoring, and grading 1L essay assignments during Orientation Week. On top of my classes, I continued being a TA for the 1L class in Civil Procedure and Lawyering Skills. Being a TA was very rewarding and allowed me to expand my network of legal professionals. Since I am fast-tracking law school, which involves higher credit semesters, the extra work was a lot to juggle on top of my courses because I was also still working remote for my attorneys in Bismarck; however, they did hire me an assistant to help with the workload (let's be honest, that is every paralegal's dream)!!

In addition to the coursework, TA duties, and work there are also other requirements students need to complete during their 2L year. Law students must begin the character and fitness investigation process by filing an application with the Board of Law Examiners by October 1<sup>st</sup> of their 2L year, or they risk incurring higher fees. Also, students typically take the Multistate Professional Responsibility Examination ("MPRE") in their 2L year. Students must squeeze in time to study for the MPRE and obtain a passing score prior to passing the Bar exam. The MPRE is only offered a few times a year, so it is important to allow yourself enough time to be able to retake it if needed. These are all things which are compounded onto an already busy schedule.

One of the biggest challenges during my 2L year was managing the demands of being a single mother with the demands of school and work. As a woman and a mother, holding it down and keeping it together for your children while tending to school and work was a real struggle for me. This is where that strong support system, which I talked about in my first article, becomes imperative. I strongly believe you are only as



good as the people you surround yourself with, which is why I keep my circle extremely small. Without these amazing people, like my assistant, my first two years of law school would have looked very different. In fact, there was a time I thought I would have to drop out of school due to family issues and my circle reminded me of why I was here to begin with. To those few people, you know who you are, thank you from the bottom of my heart.

Overall, my second year went well but without my paralegal background and the discipline that it instills, the year would have been much tougher. Just like my first article, if you are interested in pursuing law school, you are already trained to have the flexibility and adaptability to take that next step. Reach out to me and we can go into more detail on how you can begin your journey. If I can do it, so can you!

We work with sensitive matters in the legal world and sometimes need to have difficult conversations with clients. It would be helpful to have thinking teams to discuss how to convey accurate information tactfully.
- To go completely electronic, no more hard files or paper! The files/paper sure does pile up fast and I prefer to be clutter free!!!
- The parking situation, especially during session. It is not so bad in the summer, but when it's -40 and the wind is blowing you are wiped out before you even start the day!
- Truthfully, I don't have a specific answer to this question. Maybe better attention to time management (i.e. towards the end of the day, if a legal assistant/paralegal has a known appointment and their attorney hands over a time-sensitive project due before EOD which could have been handed off to their legal assistant/paralegal sooner). ### How do you handle a disgruntled client?

- If we have gone round and round without an end in sight I would ask my Attorney to handle!
- I handle a disgruntled client by listening to their concerns, taking note, and scheduling a call between them and my supervising attorney!
- It depends on the situation. If on the phone, I will try to de-escalate; explain the situation; apologize if necessary as I believe in taking responsibility for actions; if not my fault and they are yelling or cursing at me they get one warning to calm down and talk respectfully or I will end the conversation. If that doesn't work then they get transferred to my employer or I hang up on them. If in person, I put them in a conference room so that there isn't a "public" scene. Do pretty much everything as above. I do try to handle to the best of my ability before having to pull the boss in. If they are just upset about a certain event that isn't our fault and just need to vent, I will listen to them but calmly explain that they do need to lower their voice and be respectful. I will sympathize and be a listening ear. I will strategize and offer options of resolution. Fortunately, we have had very few upset clients over the years. Most of the upset individuals or ones who talk to us disrespectfully or either opposing sides or a potential client. We really do have an amazing clientele that treat us respectfully.
- I usually just let them vent, most disgruntled individuals just want someone to listen to them. I am lucky in my position that we have management's approval to terminate a call if the individual curses or gets nasty. Luckily I've not had to use that option much.
- I handle a disgruntled client, first, by indicating that since I am not an attorney, I cannot provide legal advice. However, I'll do my best to understand what I am able to help with, and if that help is not wanted and/or not enough, I indicate to the client that I cannot help anymore other than by scheduling a phone call or in-person meeting with their attorney.
- When it comes to our clients, I've found that relating to them and expressing empathy goes a long way. Understanding their situations and letting them know that I'm here to help can make a significant difference. (I think it would be great to have a do a session on de-escalation tactics to further support our clients during challenging times.)
- Remain calm and sympathetic to whatever it is they're upset about and LIS-TEN. Sometimes they just need to be heard.
- A lot of deep breaths and trying to speak calmly. I try to figure out if there is something they do not understand and the reasoning for them being disgruntled. From there, we can hopefully reach an understanding that makes the client feel better.
- When dealing with a disgruntled client I feel it is important to remain calm and understanding. This is a stressful time in their life and I want to be as compassionate and understanding as I can even though I probably cannot give them the answer they are looking for.


