At the workshops, the paralegals worked with the survivors to get all of the needed divorce forms filled out, get them reviewed by the attorneys in attendance and then have copies finalized and made so that all the survivors needed to do was to take all copies to the Clerk of Court. This organization is still in operation, 2025 marks the 20th year since incorporating.
