NAVIGATING INSURANCE IN CHILD CARE INJURY CASES

Child care related injuries occupy a unique niche in a personal injury practice. Although the harm ranges from tragic and truly unpreventable incidents, like sudden infant death syndrome, to deliberate abuse, most injuries lie somewhere in the middle. Injuries, and even deaths, result most often from negligent conditions: lack of supervision and unsafe conditions topping the list. Proving negligence is rarely the most difficult task, however. Pinpointing a viable source of recovery, most often insurance, is almost always the uphill battle.

The Licensure Landscape

North Dakota distinguishes child care providers by size, setting, and structure across six categories. "Self-declared" providers providers are home permitted to care for up to five children (no more than three under the age of two). Self-declared providers file an initial affidavit with the North Dakota Department of Health & Human Services (DHHS) and have little to no oversight thereafter. Next, in-home child care providers: family and group. Lastly, facility child care providers: child care center, preschool, or schoolage program. Licensing requirements and regulations increase with the number of children and formality of the setting.

Why does the regulatory framework matter in a negligence case? Because it dictates whether the State requires the provider to maintain liability insurance. North Dakota (through administrative code) requires facility-based child care child care providers, centers, preschools, and school-age programs, to carry liability insurance for bodily injuries and property damage. This is monitored and enforced through yearly licensing renewals. Self-declared and all in-home providers, even those that are licensed, are not required to maintain liability insurance for injuries that occur at the daycare despite caring for thousands of children across the state.

The Insurance Gap and Legislative Input

Bill 1298 In 2023, House was introduced attempting to liability insurance requirements for all licensed providers, regardless of size. However, such changes were met with heated opposition from providers, citing that such a requirement would cost prohibitive to continue operating or would increase the costs to families in such a manner that child care would be cost prohibitive. Similar changes have been attempted through administrative code, but met the same fate. This has left DHHS in a position to recommend but not mandate liability insurance coverage. This policy gap leaves a large percentage of providers at risk to be personally responsible for negligent conduct. In reality, the lack of liability insurance leaves families who have had a child injured without financial recourse.

Navigating Coverage

First, determine the type of provider. If it is a facility, it must be licensed and carry the appropriate liability insurance to be operational. You can verify licensing status https://search.ec.hhs.nd.gov/ (this also applies to home providers). Verifying should provide licensure the assurance that facility appropriately insured. If it is a home provider, a deeper dive will necessary. The only way to ensure coverage in that setting is to request documentation of liability insurance. It is not enough for the homeowner to provide documentation that he/she has coverage. homeowner's Most homeowner's policies exclude injuries arising out of a "business activity." To ensure appropriate coverage for any injuries resulting from the child care services, a child care endorsement to the homeowner's policy is generally necessary. You can request a copy of the endorsement, declaration's page, or a letter from the insurance company confirming coverage. Do not rely on a verbal assurance from the provider or the insurance agent.





Evaluating Personal Exposure When Coverage Does Not Exist

When coverage does not exist, the only avenue to turn to is pursuing a claim against the provider for personal assets. The uncomfortable reality is that most individuals do not have enough personal assets to satisfy any or all of the claim. A civil claim can be pursued and a judgment obtained, but that does not always translate to collectible funds. It is difficult to levy real property, personal property, or bank accounts. And most of those funds are either protected from seizure or are insufficient to satisfy a civil judgment. This leaves families with no financial recourse to help with medical expenses or lost wages that are a result of the child care provider's negligence.

For legal professionals and parents, understanding and navigating licensure-insurance matrix of child care facilities is overwhelming. It is important provider's always confirm the to classification. Never assume appropriate liability coverage is in place. Leverage DHHS filings where they exist. Prepare for the possibility that despite a strong negligence claim, there may be little recourse. By asking the appropriate, albeit uncomfortable, questions upfront with the provider, a parent gives their child the best chance at a meaningful recovery if the worst should happen while with a child care provider.

WHAT DO WE OWN AND WHERE DO WE OWN IT? A QUICK GUIDE FOR UNDERSTANDING MINERAL INTERESTS

Owning mineral rights comes with great opportunities – but also significant complexities. In North Dakota, oil production taxes have exceeded \$32 billion since 2008, representing over 50 percent of local tax collections annually. Since individuals often own a portion of these mineral interests, oil and gas royalties can offer enduring support to families for generations.

Nonetheless, clients often omit mineral rights from their testamentary strategies, leaving heirs uninformed. Legal practitioners are often the ones that wind up trying to unravel these mysteries, hoping to provide certainty and security for their clients.

This four-part guide provides introductory steps for clients that are not aware of what mineral interests they own. The goal is to help organize these unique assets in a way that will be manageable both for clients today and for future generations.



1. Identification

When starting from nothing, the first step in understanding mineral interests is identifying what the client owns. The quickest way to get a general understanding of ownership is through an online search through the county recorder website.

To initiate a search, obtain the client's name (as grantor or grantee) and the county of interest. This allows access to relevant deeds, leases, and other recorded documents via the appropriate county recorder's website.

In North Dakota, there are three different recorder websites to search for recorded documents:

- McKenzie County: www.mcvvault.com
- Mountrail & Williams Counties: www.idocmarket.com
- All other North Dakota counties: www.ndrin.com

While searching, make sure to note precisely how the owner's name is as it appears on the recorded document along with township, range, and section. A single middle initial may be the only difference between your client and their grandparent. The recorded documents should be able to provide a legal description of the client's interests to use for a more robust title search.

2. Verification

Once you and your client have determined the legal descriptions of potentially held mineral interests, an important but frequently overlooked next step is confirming that ownership. Title verification can bring peace of mind to clients and prevent unexpected conflicts in the future.

Some attorneys and law firms opt to conduct title searches internally to retain direct control over the process and obtain real-time insights into potential encumbrances, ownership discrepancies, or jurisdictional nuances. This approach not only streamlines communication and decision-making but also fosters deeper engagement with property law, providing legal professionals with practical, experience. However, in-house title examination can be labor-intensive and may inadvertently miss key elements, especially when evaluating mineral interests-an area known for technical complexity and unique legal attributes. These interests often involve split estates, non-surface rights, historical conveyances, and varying lease provisions that require specialized knowledge to interpret accurately. Without thorough expertise, critical issues such as severed rights, dormant improperly interests, indexed or instruments may escape detection, potentially jeopardizing the integrity of the estate plan.

a professional landman Hiring conduct title work is a practical alternative that can enhance efficiency for attorneys and staff while delivering specialized expertise to clients. This approach is often more cost-effective for the client and enables quicker service delivery. The primary challenge lies in identifying a landman who is both dependable and proficient. Building and sustaining strong industry relationships is essential to securing the right professional for the task.

Thorough title verification is essential to safeguarding a client's mineral interests. Whether conducted in-house or by a qualified landman, the process ensures legal clarity, prevents costly disputes, and supports informed decision-making. Given the complexity of mineral ownership and its potential impact on asset value, confirming title is not just best practice—it is a fundamental step in providing sound legal counsel and strategic guidance.

3. Valuation

Once a client's mineral assets have been verified, the next essential step obtaining professional а mineral appraisal. Petroleum engineers play a key role in this process, utilizing key data points to produce an informed and comprehensive valuation. Unlike surface property, mineral interests are inherently require complex and specialized expertise to assess accurately. Their value is often opaque to non-experts, professional appraisal making indispensable.

Assigning a monetary value to mineral assets unlocks numerous practical advantages. It facilitates smoother transfers of ownership in estate planning, enables accurate tax reporting, and provides critical context when evaluating offers to lease or sell. A well-supported valuation also enhances the client's ability to make informed decisions and negotiate with confidence in today's energy market.



Mineral appraisals are a cornerstone of responsible asset management. leveraging the expertise of qualified petroleum engineers, attorneys and meaningful their clients can gain insights into the true worth of mineral holdings. This not only safeguards the client's interests but also empowers and strategic transparent more transactions.

4. Estate Planning

Once identified, verified, and appraised, mineral interests can be treated similarly to other assets that make up a client's estate plan. Mineral interests can hold substantial and enduring value ongoing royalties, to agreements, and potential future extraction rights. lf not accounted for, they may be subjected to inefficient distribution, unexpected taxation, or even legal challenges. Strategically incorporating mineral rights into an estate plan can ensure they are properly valued, managed, and seamlessly transferred, preserving generational wealth and maximizing long-term financial outcomes.



Every legal professional understands the inherent value of taking proactive steps when planning for generational transfers of property. Mineral interests can be just as valuable in a client's estate as their home, farm, or bank Without clear directives, account. mineral rights can become sources of tension among heirs-particularly their income potential is misunderstood or contested. Proper documentation estate within the plan ownership, outlines succession designates preferences, and appropriate fiduciaries to manage the interests. Thoughtful estate planning, including attention to mineral assets, reflects a commitment to stability, transparency, and stewardship across generations.



Quote from Vicki Kunz: Have you ever been in a meeting and ideas or suggestions are flying and before you know it, there is that one person who is already working on it and brings the finished project to the table without being asked?! That is Candy! Whether she was at work, at a local or national meeting, Candy Reilly was engaged. She just naturally stepped up and got things done without asking her. She was not one to be in the limelight herself but made sure those around her got the credit they may have had due for their work! She served in so many capacities at work, WDALA, and NALA, her leadership came naturally, quietly and most times in the background. She has always been that person you could count on!



I started my paralegal career in 1985 with Nevin Van de Streek, Eaton, Van De Streek & Ward. Nevin was the city attorney so my job entailed municipal law, creditor bankruptcies, real estate, estate planning and trusts as well as general litigation. We used typewriters, erasers and carbon paper, the copiers did not sort and/or staple. When our office got its first computer, I was the one who learned and used it first. I also got to prepare for the first trial of many to come.

During this time, I met Dot Jorde and other legal assistants in the Minot law firms. Through these contacts, I learned about WDALA and met Vicki Kunz. Vicki and I had so much in common and, of course, she encouraged me to join WDALA. I jumped in with both feet. My first annual meeting, Vicki had me running for VP. She was president at the time.

Through WDALA, I learned about the CLA program. They did not have study guides during that time. We were told to know the Federal Rules of Evidence, Federal Rules of Civil Procedure, Legal Terms and definitions (including all Latin terms used) and cited other legal sources. We also had to pick topic subcategories ... such as litigation, contacts, real estate, etc. We formed study groups in Minot and quizzed each other. When it was time to take the exam, there were over 30 of us from WDALA at the exam! There were no computer exams, we had to write motions, briefs, essays, etc.

I became a CLA in 1991. This certification opened more doors for employment and education. In the fall of 1992, I took the Civil Litigation Specialty exam. It usually took a few months to grade exams and in January, 1993 I received my CLAS (Litigation).

As First Vice President of WDALA, I planned the quarterly seminars along with the annual meeting. At that time, they were in Minot, Bismarck and Dickinson. This was one of my favorite jobs.

During my time with WDALA, I held the following offices: First Vice President (Seminar Chair) 1991-1992; President 1993 and 1994; NALA Liaison (two years); and Historian (one year). I was also a member of the N.D. Supreme Court Professional Standards Committee that worked with the State Bar Association to develop professional standards for the work of legal assistants under the supervision of attorneys. I worked with Vicki Kunz and Brad Beehler along with three representatives from RRVLA. Those standards were adopted in 1997.

I moved to Fargo in 1996 and became a member of RRVLA for 6 years. I served as Vice-President (Legal Education) and NALA Liaison.

In 1998, NALA honored me with the Affiliated Association's Award in Colorado Springs, Colorado for my time on the WDALA Board. I attended my first NALA Convention when it was held in Bismarck, ND. I was in awe of all experienced paralegals there. I attended many more conventions after Bismarck.

My first four-year appointment with NALA was the Professional Development Committee (Chair for two years). I was the Editor of the Career Chronicle as Chair. I held this position at the same time that numerous states were working on state professional standards for the utilization of legal assistants under the direct supervision of attorneys. Many states were working on guidelines as well and we tracked their progress. The PDC also undertook a substantial revision of the NALA Code of Ethics and Professional Responsibility. I spent the fourth year on the PDC as the Ethics Chair.

The Conference was held at Harrah's Resort Atlantic City from July 10–12, 2025. This year's conference marked NALA's full return to in-person programming and commemorated its impressive 50th anniversary. With the inspiring theme, "Golden Legacy, Radiant Future," the event honored five decades of advancing the paralegal profession while looking ahead to its evolving role in the legal landscape.

Attendees could earn up to 12.5 CLE credits, with a wide range of sessions, practical workshops, and certification support designed to meet the needs of today's legal professionals. The workshops I attended included the following:

"Contracts in Concert: Music Industry Contracts" Presented by: Amber Simon, JD, LLM

Opinion: A significant portion of our legal practice involves Contract Law, so I found it especially valuable to explore how this new area of contract. While I may not directly apply this knowledge in my daywork, the session offered to-dav fascinating insights into the various types of music contracts. The speaker used several Taylor Swift examples to illustrate the do's and don'ts of contractual agreements-highlighting lessons learned from her own challenging legal battles. These real-world analogies made the concepts both engaging and easy to relate to.

"CP Review - Criminal Law" Presented by: Mekka Crawford-Franklin, Esq.

Opinion: Although I've already completed the CP exam, I chose to attend this CLE session because our office recently took on the city prosecution contract, and I wanted to deepen my understanding of Criminal Law. I appreciated that the session was clearly tailored to paralegals, which made it especially practical and relevant. While the content leaned a bit more toward the defense perspective than prosecution, I still gained valuable insights. The segments on the Criminal Case Timeline and Trial Preparation were particularly helpful. My favorite part, though, was the discussion on "red flags" in client statements—so relatable! "Feeding the Loan Shark: The Fair Debt Collection Practices Act" Presented by: Olivia Renfroe, ACP


